TABLEAU VIVANTS AT BERWICK.

On Wednesday evening, in Berwick Corn Exchange, a grand amateur entertainment, consisting of Tableaux Vivants, interspersed with incidental music, was given in aid of the funds of the Royal National Lifeboat Institution. Last year a similar entertainment was given, and was highly appreciated by a crowded house, the proceeds on that occasion being devoted to help the funds of Berwick Parish Church Mission Room. The entertainment then partook of the miscellaneous character, but on this occasion a long programme of Tableaux was given exclusively, only interspersed in each part by a violin solo. The arrangements for the entertainment were carried out by a strong committee of ladies and gentlemen, who worked hard and enthusiastically for the success of their venture. As on the last occasion a dress rehearsal took place in the afternoon, to which the inmates of Berwick Workhouse were very kindly invited. Unfortunately, some of the young ladies and gentlemen who had arranged to take part in the entertainment, were prevented from doing so on account of illness and almost at the eleventh hour the personnel of the different scenes portrayed had to be altered. A little disadvantage was thus caused, but as the sequel showed, the new-comers were equal to the task, and everything went off well. Mr L Miller acted in the capacity of manager, and explained the various tableaux previous to the rising of the curtain. The audience was first introduced to what was termed "An exciting finish," the scene consisting of three gentlemen in hunting attire, two with little girls on their shoulders, holding heavy hunting crops, and the third with a boy similarly placed, and with horn to mouth, as if urging on his pack. The sight was a very pretty one. The four seasons made a nice exhibition, and one which was generally admired. The tableau following was from the first scene of the first act of Shakespeare's King Lear, and portrayed Cordelia's banishment. It had a very beautiful effect, the grouping of the figures on the stage being very realistic, while the lime light showed splendidly upon the dresses of the actors. At this point Miss Bromby played a violin solo "Spanische Tanze" (Moakowski), in which she displayed remarkable skill in the manipulation of the instrument throughout all the difficult passages with which the piece abounds. She was cordially applauded for her effort. "Playing at tableau" was the succeeding scene, and represented two children at play, entitled "Mamma asking Pa for a cheque." The appearance was good. Two very realistic pictures followed, entitled "First words of love" after Peregeine and "Married." Both were exceedingly well executed. A representation of the wellknown song, "Simon the Cellerar," in three distinct scenes followed. The first showed Simon as depicted in the first verse of the song: while in the second Marjory was seen at "at the back cupboard behind the stairs," and watched by two domestics: and in the third Simon was found musing whether he should take ols Marjory for a wife or remain in single blessedness for ever. The three scenes were highly amusing and were done full justice to by the ladies and gentlemen in whose hands they were. The eighth tableau represented Lady Derwentwater's denunciation of her husband, who, after having fled from the reigning Monarch's soldiers that sought his

apprehension, returned in disguise to have an interview with his wife. The scene was a handsome one. "Between two fires" concluded the first part of the programme, and showed a warrior bold between two ladies, upon whom he looked with seeming indifference. The second part opened up with a capital portrayal of "The Maids of Lea" in three scenes, which were all shown to advantage. "Some familiar faces," in a number of scenes, was the title of the next piece on the programme, and these set forth the pictures daily to be seen in use for advertising purposes, by well-known firms throughout the country. First came "Pickwick," representing a firm of well-known penmakers. This was followed by Messrs Pears' "You dirty boy," and Brooke's "Monkey Brand," as represented by an ape admiring himself in the bottom of a saucepan, and sitting on the bannister of a stair. A well-known blend of tea, to which attention was drawn by a couple of ladies sitting at a table enjoying their afternoon cup, succeeded. This was followed by Bird's Custard without eggs, and the last of the series represented the well-known advertisement of Sunlight Soap. These half dozen exhibitions made an excellent lot, each one being most faithfully portrayed. Miss Bromby again varied the proceedings by another violin solo, "Air Varied" (Ernst), which she executed in a manner which left nothing to be desired. This was followed by "After fifty years," a scene representing a golden wedding celebration in which were gathered an aged couple and a numerous company of children and grandchildren. The scene was a highly interesting one. "The Girl I left behind me" followed, and, as the name implies, referred to a soldier taking leave of home and friends, and was a capital representation of such an occurrence. Another historic scene "Queen Elizabeth and Sir Walter Raleigh" was very finely depicted, the figures on the stage showing extremely well. "A Tour in the provinces," in two scenes, represented a travelling musician apparently highly impressing three young hearers. The second scene showed one of the youngsters dropping a copper in the hat of the musician, and his grateful acknowledgement of the same. The scene was realistic in the extreme. The finish was reached with a couple of scenes named "An interrupted duel." In the first, two gentlemen, swords in hands, are seen with their seconds waiting for the signal to fight, but in the next scene the duellists are interrupted by the arrival of a couple of ladies on the ground. Both were splendidly depicted. As above stated everything went off without the slightest hitch, and the ladies and gentlemen taking part in the entertainment are to be highly congratulated on their excellent appearance. Not a single movement could be observed, and the scenes depicted were highly realistic. The ladies and gentlemen taking part were: - Mesdames A L Miller, Noble, and Bell, Misses Alder (2), Bolam (2), Crossman, Sinclair (2), Blagden (2), Cahill and Smith; Messrs R Weddell, S Bell, W Bell, H Alder, A L Miller, L Blagden, R R Riddell, B J Weatherhead, H Bell, and Master Fluker. An efficient orchestra, under the conductorship of Mr George Bromby, organist of Berwick Parish Church, and consisting of the following: -First violins – Miss Bromby (leader), and Mr T W G Borthwick; second violins – Mr B Davis and Mr A Lountoun; cello, Mr W Weatherhead; piano, Miss Weatherhead; and organ, Mr Bromby, discoursed a splendid selection from the works of leading composers. In the afternoon at the dress rehearsal there was a numerous attendance, but in the evening the large building was crowded. The entertainment was a great success, and general expressions of approval were heard on all sides. At the close of the programme the Mayor of Berwick proposed a hearty vote of thanks to the ladies and gentlemen who had furnished such an excellent entertainment. He was sure that it had been enjoyed by all. (Applause.) The curtain

was then raised, when the whole company appeared, and Mr A L Miller acknowledged the compliment on behalf of the performers. It had been a great pleasure to them to get up the entertainment, and if they had pleased the audience they were amply repaid for the trouble they had taken. The proceedings terminated by the singing of a verse of "God Save the Queen." The Committee, with Miss Willoby as the energetic secretary, are to be highly congratulated on the result of their effort.

Mr A L Miller, secretary, said the annual balance sheet had been circulated amongst the shareholders. This showed that the income was £419 2s 11d, made up a follows:

The expenditure, which included £58 12s 5d for repairs and furnishings, amounted to £206 12s 4d, leaving a balance of £212 10s 7d.

Mr Miller next read the annual report as follows: - Your Directors again have the pleasure of congratulating the shareholders on the continued success and stability of the Company. The revenue from all sources has been well maintained during the year. The whole of the premises have been kept in good repair and the furnishings renewed where necessary, at an expenditure of £58 12s 5d. Notwithstanding this large expenditure, the nett profits for the year amount to £212 10s 7d, which, with the balance of profit brought forwards £5 14s 3d makes an available total of £218 4s 10d. Out of this your Directors recommend a dividend of

5 per cent per annum, carrying £13 7s 2d to Reserve Fund (which is hereby increased to \pounds 235), and carrying forward the balance \pounds 4 17s 8d to next account. With a view to strengthen the Reserve Fund of the Company, your Directors have increased the stall rent from £3 to £4 for fixed (side) stalls, and from £3 to £ 10s for moveable (area) stalls. The increased rates have been willingly paid, and the usual number of stalls have been taken. The additional income from this source will raise the Reserve Fund to satisfactory dimensions in a few years, and will enable your Directors to regard with equanimity any expenditure which may be necessary for the renewal of the roof and floor. The retiring directors are Mr H G McCreath and Mr John Black, who are eligible for re-election.

The retiring directors were re-elected on the motion of Ald. A Darling, seconded by the Chairman.

Mr J M Edney was re-elected auditor.

Mr Miller stated that the auditor had made the most searching investigation of the books and accounts. He had examined the transfer and share certificate books. He thought it a most essential part of the duty of every company to have this work done. Mr Edney had gone most carefully over the books, and that had entailed a great deal of extra work.

Ald. Black – The early shares have no certificates, but from a certain date certificates have been issued.

Mr Miller said that for the early shares bankers' receipts had been given for the money.

Mr T B Short – Could these certificates be applied for?

Mr Miller – certainly.

Ald. Black – I have certificates for all mine.

Mr Miller said the unclaimed dividend of £181 11s had this year been brought into the balance account, and shown for the first time.

The Chairman – We may congratulate ourselves on the state of affairs. I think we will go on improving.

The usual votes of thanks terminated the proceedings.

BERWICK TONIC SOL-FA ASOCIATION. The seventh concert of Berwick Tonic Sol-Fa Association took place on Tuesday night in the Corn Exchange, which was filled by a numerous and appreciative audience, who frequently showed their approval of the efforts of the various performers. The singers, who numbered about 100, were accommodated on a sloping platform at the east part of the hall. The chorus was fairly balanced, though we should have liked a stronger proportion of bass voices. The vocalists showed, in all the concerted music, a readiness and certainty of attack as well as an intelligence, which indicated that they had been carefully trained, and that they thoroughly understood what they were singing. The soloists also conscientiously performed their parts.

The first portion of the concert consisted of "The Crusader," a cantata, of which the following is the argument: - Scene 1 opens in a small town, the inhabitants of which are aroused by the pealing of bells from their quietude. Peter the Hermit announces his mission, and invites young men to join the army that is marching towards the town. The martial strains of the approaching band are heard in the distance. A young man, Christian, volunteers his services and is accepted. The bells peal forth again, the army arrives, and is welcomed by the people. Scene 2 – Christian's fiancée, Margaret, is sitting alone at home. News is brought to her that Christian is going to was. She seeks shim, and pleads with him not to go. He adheres to his resolve, and an impassioned duet ensues. Scene 3 – Warriors and people wend their way to the Cathedral, and invoke God's blessing on their mission. Scene 4 – is laid outside Jerusalem. The Crusaders are awaiting an attack from the Turks, whom they can hear chanting their prayers to Allah. A sorceress among the Turks tells of her conviction that the Cross will triumph and the Crescent be overthrown. The Crusaders march to the attack, and in the skirmish which follows Christian is taken prisoner by the enemy, who retires into the city. Scene 5 – tells of Christian's imprisonment. He dreams of home, and angels sing words

of comfort and hope to him. Scene 6 – depicts the real attack by the Crusaders, who completely rout the Turks and release Christian. Scene 7 – Margaret is again sitting alone, longing for hr lover's return, when she hears the sound of horses; the bells chime forth again, she rushes out and meets Christian among the victorious warriors who have safely returned. Peter the Hermit declares their mission ended, and all join in thanks to God for all his mercies.

The music of the cantata, which is written by Thomas Facer, the libretto being by David Gow, partakes largely of a military and religious character throughout. We are reminded frequently of bugle calls, the march of soldiers, the clashing of weapons, the pealing of bells, the chanting of prayers, invocations and thanksgivings. The choruses were sung in a tasteful and an accurate manner, which brought out their full beauty and meaning. The music was very pretty and effective, and was much enjoyed. Miss Jeannie Barker was the soprano soloist, and acquitted herself in such an admirable manner as to secure enthusiastic applause. This young lady shows marked improvement every time she appears in public, and on Tuesday night she scored her greatest success. The music allotted to her was of a somewhat difficult character, and made considerable demands upon the vocalist, but, nevertheless, she gave a highly satisfactory and pleasing interpretation of it, her best effort being "So long the day." The audience called for an encore, but the rule of the evening was to have no repetitions. The tenor solos were distributed between Mr Thos. Richardson (the conductor), and Mr A Downes, both of whom showed much skill and judgement in the execution of what fell to their share. Mr Wm Wood took the bas solos, in which he displayed once more his powerful deep voice, the effect of which would be greatly enhanced if he would exhibit some vivacity of style.

The second part of the concert was of a miscellaneous nature. The chorus sang several glees and part songs. "Foresters sound the cheerful horn" (Bishop), "We'll hae nane but Hieland bonnets here" (Roddie), and the "Drum March" (Krugh), were sung with much verve and sprightliness, while "Daughter of Error" (Bishop), and "The bonnie Brier Bush" (Roddie) were delivered with much feeling. The solo in the former was taken by Miss Barker, who added to her laurels by the manner in which she sang it. The male part song, "Stars of the summer night" (Woodbury,) was an excellent specimen of subdued singing, and it had a very fine effect. Mr Tom Barker gave as a violin solo, ""Yankee Doodle" (Vieutemps), the execution of which was marked by great digital dexterity and skill in bowing. This was an extremely creditable performance, and fully sustained the reputation Mr Barker has acquired as a violinist of no mean order. It was greeted with quite a furore of applause, in response to which Mr Barker played "Ye banks and braes." Mrs Redpath sang "Doun the burn, Davie, lad," and at first showed some trepidation, which, however, wore off, and enabled here to finish much better than she began, and with such success as to meet with hearty acclamation. Mr Wm Wood's Italian boatman's song, "Oh, Ho, hear the winds blow," had a somewhat lugubrious effect, but was a meritorious performance. In the duet, "I've wandered in dreams" (Wade), the voices of Mr Thomas Richardson and Miss Barker blended in a highly pleasing manner, and it evoked thunders of applause. The National Anthem terminated a most enjoyable and successful concert. Mr Thos. Richardson acted as conductor with his usual

ability, while Miss Wood was an efficient accompanist. The effect of the cantatas, and the concerted music in the second part of the programme was much enhanced by an orchestra, consisting of the following performers: - 1st violins – Mr T Barker (leader), Mr T W G Borthwick, Mr C Campbell, Miss Gauld. 2nd violins – Mr Davis, Mr A Lounton, Mr J Campbell. Viola – Mr B Barker. Cello – Mr Wm Weatherhead. Basses – Mr J Crow, Mr R Weddell. Flute – Mr Wm Green. Clarionette – Mr Spowart. Cornet – Mr Ludford.

BERWICK CHORAL UNION. On Tuesday night Berwick Corn Exchange was filled by a very numerous audience who had assembled to hear the members of Berwick Choral Union give at their 25th annual concert an account of their studies during the past winter. The choristers, who numbered about 100, were accommodated on a sloping platform at the eastern portion of the hall. On the whole there was a fair balance of the different parts, but the tenors were somewhat weak in numbers. The work selected for performance this year was Sir W Sterndale Bennett's popular pastoral "The May Queen." This cantata, relating to rural life, is characterised by simplicity and sweetness. The production is one of much interest and beauty and the singers proved, by the manner in which they attacked and sang the music, that they had not only mastered it thoroughly, but that they also understood and appreciated the meaning of it. There was a correctness of intonation and an attention to the nuances which indicated intelligence on the part of the vocalists, and much care in their training by the indefatigable conductor, Mr W Green, who spares no trouble to make successful any musical enterprise with which he is associated. The effect of the chorus was much improved by an orchestra, composed as follows; - first violins - Mr T Barker, Berwick (leader); Miss Lucy Gauld, Berwick; Mr J C Campbell, Berwick. Second violins: - Mr B Davies, Berwick; Mr Gibson, Berwick. Violas - Mr H Beers, Newcastle; Mr R Barker, Berwick. Cellos - Mr W Weatherhead, Berwick; Mr Jas Campbell, jun., Berwick. Contra bass - Mr G Hoggett, Newcastle; Mr J Crow, Berwick; Mr R S Weddell, Berwick. Flute – Mr J Crow, jun., Berwick. Clarionet - Mr H Spowart, Scremerston. Cornet - Mr Ludford, Berwick; Mr A Campbell, Berwick. Euphonium – Mr J Rutherford, Spittal. Pianoforte – Miss Barker, Berwick. Organ - Mr W G Green, Berwick. Tympani - Mr J L Miller. Bass drum - Mr P Crow. The following professional vocalists who, the Committee stated, were of a higher order than have hitherto appeared in connection with the Choral Union, were engaged to add to the excellence of the concert: - Miss Jessie Moorhouse, Manchester, soprano soloist from Sir Charles Halle's Concerts; Mr J A Y Stronach, Edinburgh, the popular Scottish tenor; and Dan Riffington, Leeds, bass soloist Leeds Festival, and Sir Charles Halle's Concerts. The contralto singer was Mrs Bothwick, Spittal, whose excellent performance of the alto solos in St Paul at the last annual concert was enthusiastically received.

After a suitable overture the chorus burst into spirited song. "Wake with a smile O month of May," the first number of the pastoral, was rendered with great animation. Thereafter Miss Jeannie Barker sang the short recitative "Now that the tree is drest," with distinct articulation. Then came the recitative and air "O, meadow clad in early green," by Mr Stronach, who essayed the part of the "pale and wan fond lover." To the plaintive strains the vocalist did full justice, and showed that he possessed a sweet and pleasing tenor voice of good quality, which he could exercise with much care and judgement. This and his other performances were

greeted with the heartiest plaudits by the audience. The chorus followed with "O melancholy plight," in which the state of the pallid and forlorn wooer, who was "late so bold," was bewailed in sympathetic and mournful tones. From these, however, there was a sudden change and striking contrast as the vocalists again broke forth into lively strains to the words "With a laugh as we go round." This chorus was descriptive of a May pole dance on the green, to celebrate the choice of a May Queen. At its conclusion, this monarch of the revels, who was personated by Miss Moorhouse, was introduced in a short solo, the delivery of which at once showed that the lady was a singer of great power and excellence, whose style was characterised by a liveliness and charm which captivated the audience, who rapturously applauded her various efforts. After a few more passages by the chorus and the May Queen, the lover again appears on the scene, and pleads to be heard ere the dance begins. This petition being allowed, he asks the lady why she has changed her fancy. The May Queen replies to the effect that she can find a warrant for her conduct in the firmament, in the flower, in the breezes, in the city and wilderness, ocean and bower, and tells him, "Oh, for inconstancy blame not a maiden." The lover upbraids her in pathetic tones, and asks "Why being tender delight in my pain?" The May Queen reminds him that it is no day for repining, and asks that if she be fickle "is it manly to lament?" The interchange of passages, all of which were delivered with much refinement and skill, leads up to a duet, in which the voices of the singers blended in perfect harmony. The May Queen then disappears, in response, as she alleged, to the clamour of her people gay, and the lover sees the approach of the foresters. "led by yonder boastful stranger," who proves to be the bold outlaw, "Robin Hood," a character assumed by Mr Billington. The first air that fell to his lot, "Tis jolly to hunt in the bright moonlight," was sung with a vigour, and animation, and the spirit of audacity appropriate to the sentiments, the music, and the character. It enabled Mr Billington to display the capabilities of his deep, strong bass voice, and its delivery was received with thunders of applause. After an air by the lover, in which he wonders "Can a virgin heart be won by a man so full of guile," a trio is introduced, and this was rendered by the soloists in a manner that left nothing to be desired. The greenwood king, as Robin Hood called himself, then claims sweet welcome from the May Queen, who, however, exclaims, "Not on my lips, bold man." The [next line illegible] "to stand between the wolf and the lamb." He strikes the outlaw, and the chorus, after shouting "part them," exclaims "Ill-fated boy begone." The music, it is needless to say is of a dramatic character, and received full justice from the vocalists. After some passages for the orchestra, descriptive of the approach of a pageant, the chorus again enlist attention with the words "Hark! Their notes the [haulboys] swell," in which we are told of a bright and royal show on the River Thames. "Old England's gentle Queen is then introduces, the part being taken by Mr Borthwick, Spittal, who in the recitative, "What mean the angry sounds we heard." Had scope for the exercise of a pure contralto voice, which was heard to much advantage, the words and music being declaimed with considerable dramatic force. He Majesty having ordered justice to do its work to the man who had struck the blow on royal land, by cutting off his hand, it is the turn of the May Queen to plead for her lover whose heart she "madly tried." She asks for him to set free. The royal lady asks "which is the other?" The chorus exclaim "The one who seeks his face to hide," and the Queen remarks, "What! You my lord in vile array? What would your plighted lady say! You to a village girl descend!" Robin Hood is then ordered away, the May Queen is told to wed

her admirer at morn, and trifle with true love no more, while the pastoral ends with solos and a chorus containing a number of fugal passages entitled "And the cloud hath passed away," the final strains being sung to the words "a blessing on the Queen."

The second part was of a miscellaneous character, the chorus taking no part in it whatever. The first song was "The Distant Shore (Sullivan), by Mr Stronach. To this, his pure tenor voice did full justice, and he received an enthusiastic encore, in response to which he gave "My Ain Kind Dearie," which was even more appreciated by the audience, who listened in rapt silence until it was finished. Miss Moorhouse then gave the "Laughing Song," by Auber. The best praise that we can offer of this performance is to say that it was so natural that before the vocalist had proceeded far, the large assembly was convulsed by her inimitable interpretation of the song, the spirit of which proved so infectious, that all were in a state of risibility during its delivery. In response to an irresistible encore, Miss Moorhouse sang "Comin' thro' the rye," with all that archness which the words and music demand. Mr Tom Barker next performed the violin solo, "Scene de Ballet." (De Beriot). This musician, who is now a recognised favourite with the public, showed a crispness and delicacy of touch as well as a breadth of tone which made his contribution to the programme extremely enjoyable and secured for him a well merited encore. Mr Billington next appeared on the scene, and his delivery of "I'm a Roamer." (Mendelsohn) which was characterised by verve, dash and vivacity, provoked a perfect storm of applause. On returning he sang "Simon the Cellarer," in a most effective style and was recalled a third time when he gave "I'm a Friar of Orders Grey." Mr Stronach's rendering of "Afton Water" was marked by much tenderness and pathos. He also had to come back and in response to the demands of the audience gave "Sally in our Alley" which was much appreciated. The duet of "Fairy Wand," from Wallace's opera Maritana was the last piece on the programme, and this, which was sung by Miss Moorhouse and Mr Billington, was very telling, the voices commingling in a satisfactory manner. The National Anthem terminated the most enjoyable concert ever given by the Choral Union.

It only remains for us to say that Mr W Green wielded the baton with his usual efficiency, and that much credit is due to him and the Committee of the Choral Union for providing the public of Berwick with such an excellent musical treat. Miss Barker, as accompanist, had not a conspicuous part to play, but upon her efforts depended much of the success of the entertainment, as the accompaniments by her were tasteful and never obtrusive.

BERWICK TONIC SOL-FA ASSOCIATION.

On Tuesday the members of this flourishing musical society gave their eighth annual concert in the Berwick Corn Exchange in presence of a very large audience, which without being enthusiastic was at times most appreciative. The singers to the number of about 100 occupied a sloping platform at the east part of the hall, and in front of them was a small orchestra composed as follows: - 1st violins – Mr Tom Barker, Mr C Campbell, Mr A Lounton; 2nd violins - Mr J Campbell, Mr B Davies, Miss Davies; Cello - Bandmaster Caldwell, R A; Viola - Mr A Spaven; Basso - Mr John Crow; Clarionette - Mr Spowart; Cornet - Mr A Campbell. The chorus was fairly balanced, for although the male members were in a great minority the basses and tenors made up in quality what was lacking in quantity. The manner in which the singers attacked the music showed a confidence begotten of thorough acquaintance with it; while the way in which attention was paid to the nuances on the part of the chorus and their conductor a due appreciation of the niceties of expression which were required in its interpretation. The first part of the concert was devoted to an exposition of the sacred cantata "Saul of Taurus" by T Mee Pattison. This piece does not make great demands upon vocal abilities and technical knowledge but it abounds in bright and tuneful choruses, interspersed with melodious and effective solos. The latter were entrusted to Mrs Redpath, soprano; Miss Weatherburn, contralto; Mr Thos. Richardson and Mr James Irvine, tenors, and Mr W Wood, bass. All acquitted themselves in a highly satisfactory manner, which indicated thorough appreciation and understanding of the words and music they were called upon to render. The choruses also were sung with great animation and taste, though it must be confessed, there was a certain amount of monotony about them - a fault which it is needless to say, is not to be attributed to the performers, but to the character of the work.

The second part of the concert was of a miscellaneous character. In it were various concerted pieces viz., the glees "Where art thou, beam of light." (Bishop); "Winds gently whisper" (Whittaker), for male voices only; and "Comrades' song of hope" (De Rille); the madrigal, "In going to my lonesome bed" (Edwards); and the part songs "Duncan Gray" (Macbeth); and "Jock o' Hazelbean." All these were rendered with much verve and accuracy of time and tune. Mr Tom Barker called forth enthusiastic and rapturous applause by the telling way in which he manipulated his instrument while playing a cavatina by Raff and a dance by Dancla, both of which pieces were well calculated to display his powers and proficiency as a violinist. In response to an irresistible encore he performed "Home Sweet Home" with rare sweetness and delicacy. Bandmaster Caldwell, R.A., also appeared to great advantage in his cornet solo "Star of Bethlehem" (Adams) which was rendered in a finished style that called forth hearty plaudits and a well merited encore. Mr T S Elder delivered the ever popular and well-known "Afton Water" (Hume) with a suavity of tone and a tenderness of expression that delighted the audience, who insisted upon recalling the vocalist, who substituted "The March of the Cameron Men" a song requiring a different sort of treatment, and which Mr Elder was able to give it. The only lady soloist in the second part was Miss Dalgetty, a very young amateur who acquitted herself in a most creditable manner in essaying "The Bonnie Brier Bush," her vocalisation being characterised by considerable distinctness. Mr W Wood sang "The Diver"

(Loder) and had ample scope in that piece for the display of his deep bas voice. He was heartily applauded.

The National Anthem terminated the proceedings. It remains for us to add that Mr Thomas Richardson made a most efficient conductor, and that much praise is due to him for his careful tuition of a class whose personnel is ever changing as years roll onward. Miss Wood also was a tasteful, able and unobtrusive accompanist.

BERWICK VOLUNTEER BALL. On Tuesday the thirty sixth annual Volunteer Ball was held at Berwick. Like its predecessors this, one of the principal events of the year, was under distinguished patronage, and the usual extensive preparations were made for carrying it out on a high scale of excellence. The Corn Exchange was requisitioned, and a new spring floor was laid by Messrs J Cockburn and Son, joiners, Castlegate. The decoration of the room was left in the hands of that master of his art, Mr John Crow, High Street, and his treatment of it further enhanced his reputation in that particular line. The ball room proper was screened with light blue drapery surmounted by a frieze of old gold colour while at various points half circles of glittering bayonets were placed adding to the effectiveness of the coup d'oeil. The walls of the hall were hid from view by being decked with lace curtains, and imitation marble pillars, surmounted by a blue and gold frieze. At the head of the ball room a platform was raised, and this was occupied by the orchestra. In front a capital representation of the royal coat of arms carved in oak was displayed, emblazoned with a number of miniature Union Jacks, while three rifles were piled at either side. Immediately below a large star of bayonets was affixed. Behind the orchestra a profusion of drapery was arranged with the object of assisting the music and this had the desired effect. The alcove was hidden from view by a large painting of the Royal Arms, surmounted with draperies of white and blue colours, while at either side were representations of the Berwick and Northumberland Coats of Arms. The front of the gallery was treated in a dark crimson colour with scallops of blue net muslin, while in the centre was a large star of bayonets formed on a dark blue and gold ground. The portion of the ball room underneath the gallery was differently treated from the other parts, the wall at that part being formed of gold with a frieze of bright crimson. The doorway leading into the ball room, approaching from the gentlemen's cloak room was formed of crossed rifles and white curtains; while that from the ladies' room was surmounted with crossed sword bayonets. A large assortment of Chinese lanterns was suspended all around the circle. When lighted up, the room had a very handsome appearance, and reflected the utmost credit on Mr Crow. The various rooms downstairs were utilized as ladies' and gentlemen's cloak apartments, while the Long Room upstairs was, for the time being, transformed into a bar for refreshment and supper, the purveying of which was in the hands of Mr W H Dods, High Street. For some time before the hour announced or the commencement of the proceedings, visitors began to arrive, and by nine o'clock, the hour for starting, there was a large attendance of ladies and gentlemen. The music was supplied by Bandmaster Caldwell, R.A. who had got together a well-arranged orchestra for the occasion, and which gave every satisfaction. Dancing was opened with the time-honoured Grand March and Triumph, and was led of by the Mayor of Berwick (Councillor G A Harrison) and Mrs Marshall (wife of the ex-Mayor), who were followed by Capt. Steven and Mrs Batty; the Sheriff (Mr G Batty) and Mrs Steven; Ald. R Marshall and Mrs Dr Mackay; Surgeon Captain Mackay and Mrs C L Fraser, and joined in by nearly fifty couples. The Masters of Ceremonies were Capt. Steven, Col.-Sergt W S Dunlop, Corp G Park and Priv. J D Hume, and they discharged their duties to the satisfaction of all. The secretarial work was, as it has been for some years previously, in the hands of Col.-Sergt W S Dunlop, who discharged it in a manner which not only called forth the approbation of the members of Committee, but added greatly to the success which attended the gathering. BERWICK CHORAL UNION. CHRISTMAN CONCERT.

On Tuesday night the third Christmas concert was given by the members of Berwick Choral Union in aid of Berwick Infirmary. We regret that the audience was not so large as it might have been, for although the gallery was well filled, the body of the hall was far from being fully occupied, At the last two Christmas concerts Handel's "Messiah" was performed, but this year witnessed a new departure, as the chief work undertaken was A R Gaul's sacred cantata "The Holy City." A few selections from the "Messiah" at the end of the concert completed the programme. The chorus hardly represented the full strength of the Choral Union, as a number of the members were unavoidably absent owing to colds and other causes. Owing to these reasons some of the soloists also did not turn up, and a few of the orchestra did not appear. The chorus numbered about 75, and the various parts were well balanced. The singers showed not only a thorough appreciation of the music but an intimate acquaintance with and understanding of it. The score was attacked with a vigour and certainty of intonation which could only have been the result of complete confidence on the part of the singers in their ability to perform the work, and faith in their efficient and painstaking conductor, Mr Green, to guide them successfully through the intricacies of the music. The efforts of the chorus, it is needless to say, gave great satisfaction and pleasure to the audience, who frequently testified their approbation by hearty applause. The vocal music was considerably enhanced by the following orchestra: - First violins - Mr T Barker (leader), Mr B Davies, Mr J C Campbell and Mr W Short; second violins – Mr A Weddell, Miss Lucy Gauld and Mr George Richardson; viola – Mr A Spaven; cellos – Mr W Weatherhead and Miss S Barker; contra bass – Mr J Campbell, jr; flute – Mr J Crow, jr; clarionette – Mr H Spowart; trumpet – Bandmaster Caldwell, R A; organ – Mr A W Tomlyn, Mus. Bac.

The "Holy City" was composed expressly for the Birmingham Festival of 1882 by A R Gaul. It is divided into two parts, one descriptive of contemplation, and the other of adoration. The treatment of the subject work is almost entirely reflective, the more dramatic parts of the book from which many of the numbers are taken, viz., "The vision of St John," having already been treated in a masterly manner by the great German composer, Louis Spohr in his oratorio, "The Last Judgment." The first part of "The Holy City," was suggested by the passage of Scripture - "Here have we no continuing city," "Thy Kingdom Come," and sets forth the desire for a higher life, as expressed in words – "My soul is a thirst for God," – which desire is followed by other passages expressive of the perfection of the higher life, such as "Eye hath not seen." The second part was suggested by the words "I saw a new heaven and a new earth, for the first heaven and the first earth were passed away," thus realising the desire and promises contained in the first part. With the exception of two hymns, a verse from Milton, and three verses from the Te Deum, the words are entirely Scriptural. The work has gained high encomiums from musical critics in London and the provinces. It is generally admitted to indicate on the part of the composer the gift of melody, and an excellent knowledge of effective choral writing. Several of the choruses are light but graceful in their movements. To our mind - "Thine is the Kingdom," "Let the heavens rejoice," and "Great and Marvellous are Thy Works," are the best, being characterised by a massiveness and imposing effect. These, as well as all the others, were rendered by the singers in a manner that left nothing to be desired. The overture and intermezzo illustrative respectively of contemplation and adoration are melodious and were performed with much skill and taste.

Mr A Dowens sang "No weeping yonder" with considerable pathos and sweetness; the voices of Misses Franklin Hobbs, Messrs Dowens and Grahame blended nicely in the quartette, "No parting yonder;" Mr F Kirkby rendered "My soul is athirst for God," in a conscientious

manner; the trio, "At eventide it shall be light," by Misses Campbell and Nicholson has a nice effect; Miss Hobbs did justice to the solo, "Eye hath not seen;" Mr John Wood exercised his powerful bass voice to advantage in "A new Heaven and a new Earth;" the pianissimo, "Sanctus," which followed it, was rendered with judgment by Misses Biddle and Franklin, Misses Green and Dickinson, Messrs Kirkby and Dowens, Messrs W Green and Grahame; while Mr P Richardson sang with care "To the Lord our God." The next solo, "Come ye blessed," was to have been taken by Mrs Dickinson, but in her absence it had to be performed at very short notice by Miss Green, who sang its fluent melody with great success. Miss Campbell in "These are they which came out of great tribulation," displayed much vocal agility and power, her performance being a distinct improvement upon previous efforts. The duet, "They shall hunger no more," was sung by Miss Franklin and Miss Green, the former being substituted for Miss Summers at the last minute. Notwithstanding this drawback the music did not suffer, and the duet created a pleasing impression. The quartet, connected with the chorus, "List! The Cherubic Host," was taken by Misses A Wood and Nicholson, Green and Dickinson, the soprano and bass solos being allotted to Mrs Biddle and Mr W B Dickinson, all of whom made the most in their power of the tasks with which they were entrusted. The quartet associated with the concluding chorus, "Great and marvellous are Thy works," was sung by Misses Wood and Nicholson, Misses Green and Dickinson, and Mr W G Green in a satisfactory manner. The orchestral accompaniments were performed with much judiciousness.

The second part of the programme was devoted to a few selections from Handel's "Messiah." The first was the recitative, "Comfort ye," which was sung by Mr A Dowens with much purity of tone and clearness of expression. This was followed by the chorus, "And the glory of the Lord," which was rendered with much energy. Mr W Green next rendered the recitative, "Thus saith the Lord," and the air "But who may abide," with considerable power, the runs being delivered with much fluency. "For unto us a child is born," and the "Hallelujah Chorus" were each delivered with correctness and verve, the audience standing while the last, which brought the concert to a close, was being sung.

Mr W Green, who again acted as conductor, wielded the baton with his accustomed judgment and ability. The thanks of the public are due to him and the Choral Union for affording them another musical treat, and the only regret is that their efforts do not secure a greater amount of recognition. Miss Barker displayed her usual efficiency at the harmonium, her accompaniments, which were never obtrusive, being marked by much taste.

The Affairs of Mr S M Holmes. – An adjourned meeting of the creditors of Mr S M Holmes was held in the Corn Exchange, Berwick ,on Friday afternoon. Mr A I Brown, representing the Scremerston & Shoreswood Coal Company was in the chair. Mr A L Miller, trustee of the estate, submitted a report, in which he stated that he had made enquiries into the matters mentioned at last meeting. He had to report with regard to Holmes Brothers, he had a copy of

that firm's deed, in which it was set forth that Mr R []?] Holmes and Mr S M Holmes were the partners. The firm's books had been badly and irregularly kept, and were now being made out up to date by Mr Paulin. Approximately Mr S M Holmes was indebted to that firm £734 9s 5d, therefore, any hope of that estate being benefitted by that [?] was dispelled; in fact it was the other way [on?] as the firm of Holmes Brothers had a right to make [?] creditors. In regard to the Northumberland [?] Company, Mr Holmes and the auditor of the Company, Mr Dingwall, had given him the opportunities for enquiry, and he found that Mr Holmes had no capital, and never had any capital in the Company. He had kept no cash book and the disbursements of monies could only be [?] by coincidences of dates. The statement of [?] showed that the total liabilities amounted to £3,958 5s 11d, of which £247 18s were [?] claims. The assets were £1,588, and after deducting preferential claims the surplus left amount to £1,340 2s, leaving s deficiency of £2,623 3s 11d. The assets were equal to 6s 8d in the £.In reply to questions, Mr Miller stated that Mr Holmes kept no cash book in dealing with these financial transactions. The Chairman said it seemed the accounts had been kept in a very loose way. Mr Miller said it was very loose indeed; the [?] actions could not be traced at all. Some [?] took place in regard to Mr Holmes's [?] with the Northumberland Dairy Company, Mr Holmes having said at the last meeting that he was not a partner in the concern. Mr Miller said that a man who participated in the profits was a partner. He had made full enquiries, and he was satisfied that there were no assets to be derived from that Company to benefit this estate; there were no profits. Mr Holmes was questioned on several points. Asked by Mr Miller as to what he had done with [?] monies he replied that he could not say [?] get the money, but some of his creditors did [?]. About the time in question he began paying in cash, and not by cheque. In reply to [other?] questions, debtor replied that he had been connected with the Northumberland Dairy Company for about twenty months. His travel expenses were charged to that Company and went through its books. Some of his [?] was transferred to the Northumberland Dairy Company, from which he had been paid. After some further conversation it was agreed that Mr Holmes was given until Tuesday to find security to the satisfaction of a committee of inspection for [the rest of the article illegible].
